

# Memorandum of Understanding (MoU)

Between

**Power Sector Skill Council**

And

**SunRise University, Alwar, Rajasthan**

## 1. PREAMBLE

This MoU is executed on the 7<sup>th</sup> Sep 2022 between Power Sector Skill Council, **Plot No. 4, Institutional Area CBIP Building, Malcha Marg, Chanakyapuri, New Delhi, 110021** [here in after called Power Sector Skill Council] and **SunRise UNIVERSITY, ALWAR, RAJASTHAN**, a leading University in the country.

Whereas Power Sector Skill Council and SunRise UNIVERSITY, ALWAR, RAJASTHAN desire to have a long term association for academic collaboration for various objectives mentioned in this MoU initially for a period of 3 years which will be reviewed for further extension or otherwise on mutually agreed terms and conditions.

## 2. OBJECTIVE

The main objective of this MoU is to start long term collaboration between Power Sector Skill Council and SunRise University, Alwar, Rajsthan in various areas of business and organization development for Power Sector Skill Council. Some of the areas identified for such collaboration are as follows:

## 3. SKILL DEVELOPMENT PROGRAMMES

**3.1** An organization's talent is its most critical competitive edge for its growth in fast changing environment. SunRise University, Alwar, Rajsthan and Power Sector Skill Council would work together in finalizing programmes for the students and stakeholders in the domain of electrical and other allied domains.

### 3.2. FACULTY

The faculty for these modules will be drawn from Faculty members of SunRise University, Alwar, Rajsthan as well as experts from industry including Power Sector Skill Council. Training of trainers programme shall be conducted for teachers so as to update their knowledge & enhance their skills.

### 3.3. PROFESSIONAL FEE

The programme fee will be decided at the time of finalization of programmes after mutual discussion with representatives of SunRise University, Alwar, Rajsthan and Power Sector Skill Council.

## 4. EXECUTIVE EDUCATION

4.1 Upgrading the education level of certain set of executives on continuous basis helps the organization in remaining at the forefront of latest developments and ensures honing its capability to deal with uncertain and unpredictable times. Power Sector Skill Council will work out procedures to nominate Power Sector executives to various executive educational programmes offered by SunRise University, Alwar, Rajsthan.

4.2 The number of nominations to be sent by Power Sector Skill Council and the fee structure will be finalized subsequently by both the representatives of Power Sector Skill Council & Sunrise University, Alwar, Rajsthan.

4.3. The procedures for selection of candidates for the above courses for Power Sector may be finalized based on the mutually agreed terms and norms.

## 5. CONSULTANCY

5.1 Organizations will hire the services of management consultants for a number of reasons, including gaining external (and presumably objective) advice, access to the consultants specialized expertise, or simply as extra temporary help during a one-time project, where the hiring of more permanent employees is not required. Power Sector Skill Council may utilize the expertise of the faculty of SunRise University, Alwar, Rajsthan in dealing with various challenges faced by it in the form of consultancy projects. Similarly, SunRise University, Alwar, Rajsthan may require the services of Power Sector Skill Council experts in the areas of management and leadership. Both the organizations can mutually take up the consultancy assignments.

5.2 As per the MoU with Power Sector Skill Council the faculty will assure the privacy of the content of the consulting outcome. The report will be presented to the client in the due format as per agreed terms and conditions.

5.3 Financials and other terms and conditions of the consulting assignments will be decided mutually specifically to the programme and will depend upon duration of the project, expertise required, research inputs and other incidentals.

## 6. GENERAL CONDITIONS

### 6.1 Force Majeure

6.1.1 If either party is temporarily unable by reason of force majeure to meet any of its obligations under this MOU and if such party gives to the other party written notice of event within fourteen (14) days after its occurrence, such obligations of the party which he is unable to perform by reason of event shall be suspended for as long as the liability continues.

6.1.2. Neither party shall be liable to the other party for loss or damage sustained by such other party arising from any event.

6.1.3. The term "Force Majeure", as employed herein shall mean act of God, strikes, war, civil riots, Fire directly affecting the performance of the MOU, floods, change in law and regulations not within the control of either party and which by the exercise of due diligence neither party is able to overcome.

## 7. SECRECY

Both SunRise University, Alwar, Rajsthan and Power Sector Skill Council shall during the tenure of the MoU and at any time thereafter maintain in the strictest confidence all information relating to the work and shall not, unless so authorized in writing by either of the parties, divulge or grant access to any information about the work or its results and shall prevent anyone becoming acquainted with either through them or their personnel. Both the parties shall not avail of the information obtained in the course of work hereunder in any manner, except for the internal purpose alone.

## 8. Term of Agreement

This agreement shall come in force from the effective date of this agreement. i.e, 7<sup>th</sup> Sep 2022 and shall be valid till 07 Sep 2025 or unless terminated by either party giving 3 months' notice to the other without assigning any reason.

## 8. REVIEW

It is mutually agreed that for successful execution of this MoU, there will be an Advisory Board consisting of two senior level executives as nominated by CEO, Power Sector Skill Council and two Professors as nominated by Registrar, SunRise University, Alwar, Rajsthan who will undertake periodic review of the progress of various activities undertaken in pursuance of this MoU. The Advisory Board (consisting of four senior level executives) will also monitor the qualitative aspects of the various



programmes and deal with all issues related to coordination between two organizations and provide necessary advice from time to time in this regard

This MoU shall come into force as soon as it is signed for all purposes and intent and shall, unless earlier terminated by mutual consent, remain in full force.
